The June 1, 2026 Mifflin Township Board of Trustee Meeting was called to order at 7:00 p.m. by Chairman Timothy Echelberger. Trustee present was Eric Oswald, Daniel Atterholt and others in attendance were Twp. Fiscal Officer, Shannon Schaub, Fire Chief JJ Bittenger, Assistant Fire Chief Randy Jackenheimer, Mifflin road worker Kyle Reynolds and Mifflin Township resident David Seiss.

Kyle Reynolds stated 1255 was taken care of today and the trustees said a mower has been down but repaired yesterday so residents will see improvement this week. David Seiss asked about roads being chipped and sealed this year, Trustee Oswald said with the oil prices decline they will then address residents what roads will be taken care of.
