We are going to drain the new Firetruck until we can get it into a building with heat. The Brush truck needs repairs made to the Water Tank, it was damaged at a grass fire in Hayesville, we were supplying mutual aid.

Fiscal Officer John M. Bartley stated he has a meeting in Columbus put on by the Auditors office on December 5, this is about using UAN to close out the books for the year. We received \$50,500 from the sale of the old Emergency Squad, this was added to the Fire Department fund. The County Association meeting is Saturday December 14 at 8:00 am, this will be held at the Polk Fire Department. We are registered to for the OTA Winter Conference.

The garage doors on the new Township Building are supposed to be installed by Wednesday November 27, Once they are installed we will either buy or rent a heater for this building so it can be used. A Children at Play sign has been installed on Township 1165. The Trucks are ready for the winter to spread grit and salt.
