Volunteer Firefighter Chief J. J. Bittinger wants to buy 4 Emergency Accident Scene Ahead signs, these will be 4 x 4 and be Reflective Purple. The Fire Department Christmas is going to be December 18, 2024. The crew Had the New Emergency Squad on a call Sunday evening October 20, 2024 and hit a deer, there was no damage to the squad. The Polar Plunge will be held at Pleasant Hill Lake this year due to Muskingum lowering the lake more than normal to the winter pool, the Fire Department will be providing assistant since they have the experience.

Assistant Chief Randy Jackenheimer stated we need new batteries for the Lucas 2 Device. He is going to check pricing.

Fiscal Officer John M. Bartley stated that our Medicaid MCO should generate \$4,800.00 starting in 2026. We received from Melvin Yoder two quotes for tearing off all the old metal on the salt shed and replacing it with new, cost is \$10,178.00. He also quoted putting on 1 x 4 lumber and attaching metal to the East and South Side of the current building for a cost of \$9,876.00. He is going to put this on his books for next spring. He will look at pricing again before we commit to this.

Trustee Discussion Items

Received a message from Deb Cole. "Good Afternoon. Question the Village pays taxes to the Township, I am very interested in WHY the Township has decided Not to help the Village. I have heard why and personal agendas . . . opinions should not affect what a couple of tax payers say or piss off officials. There is more than 1 taxpayer in this Village. When is the next township meeting?" Tim responded, "For one the village pay taxes for fire service only. No road tax money comes from the Village. This is why we have decided not to get involved with village issues. Our meetings are posted on our website. I suggest you get your facts correct before you call out people. The Village does not support the Township Road Department at all. That is the equipment that we use. Thank You."
