Assistant Chief Randy Jackenheimer stated we received \$1,500 for EMS Grant, we will purchase items from the approved list and submit receipts to be reimbursed. On November 12, 2024 we will host The Ashland County Firefighters Association meeting.

Fiscal Officer John M. Bartley stated that we have renewed our SAMS number, we are good thru September 2025. Presented a revenue statement showing the first three quarters of the year, we are at 94% of expected revenue. There is a mandatory Fiscal Officer training course that will be held on October 30, 2024 in Columbus Ohio.

Received 1 bid on the building the new Fire Station. Four different companies signed for receiving drawings, 3 companies chose not to submit bids for various reasons.

The 1 bid was opened submitted by CJ Properties, this bid was for \$430,000.
