The September 8, 2026 Mifflin Township Board of Trustee meeting was called to order at 7:03 p.m. by Chairman Timothy Echelberger. Trustee present was Eric Oswalt, Daniel Atterholt and others in attendance were Twp. Fiscal Officer Shannon Schaub and Fire Chief JJ Bittinger.

The minutes of the August 17, 2026 Mifflin Township Trustee Board Meeting were sent to the trustees for review.

Correspondence: OTARMA sent 2027 policy, Trustees want OTARMA representative to come for a meeting to talk about why price has went from \$31,000-\$35,000 for coverage. Township has received Columbia Gas paper work about gas well drilling that would affect 1 parcel. Wellington Implement sent a quote on purchasing used equipment, trustees were not interested. Columbia Gas has sent a bill about hitting a line in 2025, Fiscal Officer Schaub is looking into it.

Reports: Chief Bittinger received a donation from Ashland Elks in the amount of \$1005.00 for an Electric Vehicle plug that would disable a EV vehicle from movement if there was an accident. Mifflin Township, Ashland and Ruggles Troy received the donation. Chief talked about getting price quotes on 7” ballard covers for new station, so far he has seen prices of \$50-60 each. The new fire station will need 2 desktops and 3 labtops, Chief is going to see about association covering cost. Chief is looking into new office furniture and appliances for station. Filler neck on engine is leaking fuel when filling up, trustees are going to take a look at it.

Fiscal Officer Schaub is going to contact OTARMA for an onsite visit and contact about covering cut of Columbia Gas and Frontier lines. Updating fire/EMS phone and tablets, last update was 2019. Ordering no parking fire lane signs for new site.

Trustee Discussion Items

Update of Fire station: Concrete is complete on outside. Goal of metal to be complete on inside by end of week. Trim will be installed in administrative wing next week. Exterior doors will be painted black and interior doors white on inside. Trustees will be moving flag pole, washer, compressor this week and next.
