The March 2, 2026 Mifflin Township Board of Trustee Meeting and Organizational Meeting was called to order at 7:10 p.m. by Chairman Timothy Echelberger. Trustees present were Daniel Atterholt and Eric Oswald. Others in attendance were Twp. Fiscal Officer, Shannon Schaub and Assistant Fire Chief Randy Jackenheimer.

26-038 A resolution was made by Mr. Oswald to approve the minutes as sent to the Trustees for review, second by Mr. Echelberger. Roll call results: Atterholt – yes. Oswald – yes. Echelberger-yes.
