The August 5, 2024 Mifflin Township Board of Trustee Meeting was called to order at 7:00 p.m. by Chairman Tim Echelberger. Trustees present were Tim Echelberger, Eric Oswald and Dan Atterholt. Others in attendance were Twp. Fiscal Officer, John Bartley, Volunteer Firefighter Chief J. J. Bittinger, Volunteer Firefighter Assistant Chief Randy Jackenheimer, Volunteer Firefighter Jean Sidle.

The minutes of the July 15, 2024, Mifflin Township Trustee Board Meeting were sent to the trustees for review.

Reports:

Volunteer Firefighter Chief J. J. Bittinger stated the New Squad is now in service. The Pancake Breakfast will be held this Saturday August 10, 2024.

Volunteer Firefighter Assistant Chief Randy Jackenheimer stated they are still waiting to hear back on the EMS Grant.

Fiscal Officer John M. Bartley stated the Rent for the Vesper property for July was received on July 31, 2024. Rent is still due for May 2024 and now August 2024. The Village stated that the Sewer Payment for the rental house is behind and if not caught up the Village will start charging the Township for the Sewer Charges. We are finally able to access the Medicount Portal and we have reconciled our payments for 2024, our total revenue is down by 25% from 2023. We received a quote from VFIS for insurance to cover the Volunteers from Accident and Disability, we currently are using McNeil and Company.

Trustee Discussion Items

Replace the Gasoline Tank and have it replaced with a second Diesel tank and will look into getting a smaller gas tank for Rec Fuel.

Sending the renters of the Vesper House a Letter putting them on notice that they have 30 days to get caught up on the back rent and getting caught up on the sewer bill or we will have to start eviction notice.
