Volunteer Firefighter Assistant Chief Randy Jackenheimer stated they are still waiting to hear back on the EMS Grant.

Fiscal Officer John M. Bartley stated the Rent for the Vesper property is still due for April and July. We received a refund for Federal Taxes from the IRS, this was for taxes that were overpaid for March 2024. The amount was for \$1,891.45 plus Interest of \$22.04. We received a Grant Check from Muskingum Watershed Conservancy Foundation for \$5,000, this is to be used for the New Squad. We were awarded a \$3,375.00 Grant for BWC for the purchase of a tarping system, the Total cost for the tarping system is \$4,500.00.
