Volunteer Firefighter Chief J.J. Bittinger stated the Firetruck is complete and we will receive possession of it soon. There will be a training session on how to use the new pump system. The Mifflin Village had a structure fire, the department was there quickly and we had great mutual response aid from the local departments. A discussion was held concerning the potential donation from the Hayesville Amvets. They would like us to attend their next meeting on Thursday May 16, 2024. They are interested in purchasing some needed equipment for the new Firetruck and Squad. JJ is getting quotes for needed supplies. We also discussed making Active Shooter Packs Trauma Bags, these will cost around \$300.00 each, we will present these to the Hayesville Amvets also.

Fiscal Officer John M. Bartley stated the Grant Money for \$10,000 from Samaritan Foundation, to be used help pay for the new squad, has been received. Made note to the Trustees that the Renters just paid April Rent on May 6, 2024. They are currently one month behind this year. Ashley Brown has our new website up and running. Presented an updated Schedule of Debt for the Township, this includes the New Squad. Broke down the Schedule by month for this calendar year, showing we are going to have to move some

money around in a couple of different funds, we do not have to have approval from the County Auditor since these will be inter fund transfers.
